C.3.25 Water testing

C.3.25.1 Prior Testing of Roof

The Contractor shall be responsible for evaluating all identified Roof Leaks in accordance with ASTM Standard D7053/D7053M-11, Standard Guide for Determining and Evaluating Causes of Water Leakage of Low Sloped Roofs.

The evaluation results shall be used as a basis for making repairs.

C.3.25.2 Prior testing of windows, doors, and skylights

The Contractor shall be responsible for testing all identified window, door and skylight locations in accordance with ASTM Standard E1105, Test Method for Field Determination of Water Penetration of Installed Exterior Windows, Skylights, Curtain Walls, and Doors by Uniform or Cyclic Static Air Pressure.

The test results shall be used as a basis for making repairs.
