Unfortunately, this ruling has left many unanswered legal questions that are currently being reviewed by the OAG. The guidance below is to assist members in making immediate enforcement decisions until these legal issues have been resolved.										
This ruling only applies to handguns and does not apply to long guns or shot guns which are still illegal to carry in the District.

Under the current ruling, possession of a firearm outside of the home or business in and of itself MAY NOT be criminal. For example, a District resident that has a legally registered firearm may legally possess it outside of the home or business. However, District residents are still PROHIBITED from possessing a firearm that is not legally registered in the District. District law requires proof of registration. (See attached for proof of registration).										
These changes do not prohibit officers from making arrests for crimes committed with a firearm or seizing weapons used in a criminal act.
