n October 21, 2009 the Metropolitan Police Department held the ninth Next of Kin (NOK) meeting at the Police Academy. Families of open 2009 cases met with the Detectives and Sergeants to discuss the progress of their loved ones' homicide cases. One mother expressed how she appreciated having an opportunity to communicate

her questions and concerns in person, as opposed to the phone. Even in cases where there is little, or no new information to share, families still value having the opportunity to be heard in a personal one-on-one meeting. The Family Liaison Specialist Unit (FLSU) also took this opportunity to strengthen their relationship with each family, and to remind them

that the unit is here to assist them with their individual needs. The families were also provided with referrals and resources to various community-based organizations. This meeting was also timely for FLSU to connect families with organizations providing toys for Christmas. The next NOK meeting will take place in April 2010.

Frequently Asked Questions About Crime Victims

Q: Can remembering my loved ones serve a positive purpose during the holiday season?

A: Engaging in events or activities to remember your loved one can allow you to cope with your grief in a constructive way. Commemorative activities are effective and meaningful, whether held privately or collectively, when they have significance to both the deceased and to the survivor.

Q: What are some ways to honor my loved one's memory?

A: Continue a tradition that you shared with your loved one, or start a new tradition.

- » Prepare a favorite meal enjoyed by your loved one. Go to their favorite restaurant.
- » Plant a tree, shrub, or other plant in their memory; put a plaque/marker dedicating a plant/tree that is already rooted in the ground.
- » Light a candle in honor of your loved one on special

- occasions or certain times of the day.
- » Play music, watch a film, or enjoy a book they enjoyed.
- » Journal memories, write your loved one a letter, or compose a song at: http:// www.customcraftedsongs. com/howitworks/
- » Become an activist in the community or volunteer for an organization in memory of your loved one.
- » Create a memory scrapbook with photographs, letters, postcards, and other memories from your life together.
- » Visit your loved one's burial site – you may bring flowers, release balloons, or just sit quietly.
- » Memorialize your loved one in cyberspace by creating your loved one's very own memorial website. Your memorial offers the ability to upload photographs, audio, videos, a timeline, and your loved one's personal story. Visitors to your memorial will also be able to light virtual can-

dles, leave tributes, condolences and write down their memories of the deceased.

- » Memory box write down a memory to share and deposit in the box so they can be read & reread for years to come.



Outreach Activities

- he Victim Services Branch (VSB) of the Metropolitan Police Department is committed to assisting victims of crime and highlighting the resources available to the families and survivors of homicide cases. In our continued efforts to support and empower these families VSB has participated in many events monthly throughout the city to provide awareness of the supportive services offered. The following are highlights of the important events that took place these past months which VSB was actively involved.
- » The National Day of Remembrance (Commemorative Symposium & Ceremony) was held at the Ronald Regan Building on Friday, September 25, 2009 and sponsored by three organizations: Parents of Murdered Children, Inc., Mothers Against Drunk Driving and Maryland Crime Victims Resource Center, Inc. The Victim Services Branch played an integral role in this event as one of the selected panel presenters. This event gave friends and families an opportunity to come together in remembrance of their love one's loss to homicide and to learn about different organizations and services offered to survivors of crime.
- The 26th Annual National Night-Out citywide kickoff celebration was held on Tuesday, August 4, 2009. It is designed to heighten crime and drug prevention awareness, generate support and participation in anti-crime initiatives, and to strengthen police and community partnerships. The VSB staff provided information tables and disseminated pamphlets about homicide, sexual assault, hate crimes, domestic violence, and same sex crimes to attendees from different Wards in the District.
- A Mother's Summertime Tea event was held at the Willard Intercontinental Hotel on Sunday, August 31, 2009. This free event was in recognition of survivors of homicide and victims of violent crimes with a focus on promoting healing. The Victim Services Branch (VSB) staff assisted in bringing together approximately 200 people consisting of friends, families, counselors and victim advocates to attend this event to provide support, guidance, and encouragement to the survivors of crime.
- A Queen For A Day event was held on Thursday, October 29, 2009 for survivor victims of domestic violence. This event was

- sponsored by Breaking the Silence East Of the River Committee (BSERC), which the Metropolitan Police Department, Victim Services Branch (VSB) is a member. The purpose of this committee is to raise awareness about domestic violence and provide training to the communities located East of the Anacostia Rivers in Wards 6, 7, and 8 in the District of Columbia. This event gave 25 survivor victims of domestic violence an opportunity to feel like a "Queen For A Day" by each obtaining facials, manicures, pedicures, and other pampering activities to enhance their self esteem.
- 7th District Domestic Violence Summit was held at Patterson Elementary School on Saturday, October 17, 2009 and sponsored by Metropolitan Police Department. In recognition of Domestic Violence Awareness Month the Victim Services Branch (VSB) and other local community base service providers were in attendance for this summit. The VSB staff arranged an information table which provided brochures on domestic violence, sexual assault, victims rights, and the crime victim compensation program.

Coping with the Holiday Season

he Metropolitan Police Department recognizes that this time » of year and the anticipation of holidays can be a difficult time for families and friends that have lost a loved one to homicide. Some families have found that the act of recognizing the holiday season as a sensitive time empowers them to take charge of the season, rather then allowing the season to control them. Here are some helpful tips to help you cope with the holidays.

» Plan for the approaching holidays. Be aware that this might be a difficult time for you. The additional stress may affect you emotionally, cognitively and physically. This is a normal reaction and it is important to be pre-


pared for these feelings.

- » Recognize that holidays won't be the same. If you try to keep everything as it was, you'll be disappointed. Doing things a bit differently can acknowledge the change while preserving continuity with the past.
- Be careful not to isolate yourself. It's alright to take time for yourself but don't cut yourself off from the support of family and friends.
- Avoid additional stress. Decide what you really want to do, and avoid the activities you don't wish to participate.
- » Try to remember that you will receive cards from

- well-meaning people who are hoping for your holidays to be happy. You don't have to read them. Just tuck them away for another time. Don't feel you have to reply at all.
- Avoid eating lots of sweets during the holiday. Sweets tend to make us more depressed.
