# NATIONAL NIGHT OUT SET FOR THIS TUESDAY, AUGUST 7

On Tuesday, August 7, thousands of DC residents are expected to join with their neighbors, police officers and other community leaders in celebrating National Night Out (NNO). From community cookouts to open houses – block parties, candlelight vigils and athletic events – DC is gearing up for the 29th annual celebration of "America's Night Out Against Crime." The citywide kickoff has been changed. It will now begin at will begin at 6 pm at the Rosedale Recreation Center in the Fifth Police District. Public safety characters McGruff the Crime Dog<sup>®</sup> and the National Knight<sup>®</sup> will be available to meet attendees and have their photos taken. In addition to the numerous activities taking place at the kickoff event, communities across DC – in all seven police districts – have scheduled NNO events during the late afternoon and evening hours.

National Night Out is an annual event, sponsored by the National Association of Town Watch, that takes place on the first Tuesday in August. Each year, the Metropolitan Police Department actively participates in National Night Out by rallying community members throughout the District of Columbia to join with neighbors and police officers in their PSAs to be a part of this annual event.

The National Night Out campaign involves citizens, law enforcement agencies, civic groups, businesses, neighborhood organizations and local officials from 9,500 communities from all 50 states, US territories, Canadian cities and military bases worldwide.

# METROPOLITAN POLICE EXPAND LITTERING ENFORCEMENT PILOT PROGRAM

August 1, 2012, the Metropolitan Police Department (MPD) began Phase II of the Littering Enforcement Pilot project by expanding to the Sixth District. Phase I of this pilot began in the Fourth District on May 1, 2011. Members of the Sixth District will now be able to enforce laws against littering by writing Notices of Violation (NOVs) for pedestrians observed littering.

Throughout August, MPD will issue warnings to violators as they work with community partners to educate the public about littering enforcement. Beginning September 1, 2012, anyone violating the city's littering law in the MPD's Sixth District (which covers much of Ward 7 and a small portion of Ward 8) may be issued an actual NOV or be subject to arrest.

If an officer sees an individual intentionally or carelessly dropping waste material of any source on public space, in waterways, or on private property not controlled by the individual, he or she may receive a \$75 Notice of Violation (NOV) for littering. Failure to properly respond by following the instructions on the back of the NOV will result in additional penalties.

Those cited are required to provide an accurate name and address to the issuing officer. Those who refuse or fail to provide an accurate name and address can be arrested. Upon conviction, non-cooperative litterers will be fined an additional \$100 to \$250 by the D.C. Superior Court.

While the pilot is in effect, MPD will continue citywide enforcement of the prohibition against disposing, causing, or allowing the disposal of litter from a vehicle on any public or private property, subject to a \$100 traffic ticket.

# NEW AUTOMATED SPEED ENFORCEMENT LOCATIONS DEPLOYED CITYWIDE; WARNINGS TO BE ISSUED THROUGH SEPTEMBER 2

On July 31, 2012, the Metropolitan Police Department announced the deployment of new automated speed enforcement locations. The deployment locations for the Photo Enforcement Units will continue to be at sites with the highest number of crashes and injuries, calls for police service, and high speed volume. MPD also considered recommendations or requests from the Department of Transportation, Advisory Neighborhood Commissions and civic or citizen associations.

The 30-day educational phase will commence on August 1, 2012, when violators

will begin receiving warning citations. On Monday September 3, 2012, MPD will begin issuing live moving citations to violators. The new photo enforcement locations are as follows. Unless noted the speed limit is 25 mph:

- » 200 block 17th Street, NE (southbound)
- » 1800 block Harvard Street, NW (northwestbound)
- » 1700 block North Portal Drive, NW (southwestbound)
- » 700 block Franklin Street, NE (westbound)
- » 1400 block New York Avenue, NE (northeastbound) (35 mph)
- » 3700 block Massachusetts Avenue, SE (southeastbound)
- 4300 block Texas Avenue, SE (southbound) »
- » 4800 block Texas Avenue, SE (northbound)
- » DC295, 0.4 miles south of Burroughs Avenue, NE (southbound) (45 mph)
- 2200 block K Street, NW (westbound) »
- 400 block Riggs Road, NE (northbound) »
