As of 1400 hours, numbers were drawn for First Amendment Activity CCN [REDACTED]

As of 1415 hours, the coordinator of the group at Howard, gathered near Georgia Ave NW and Euclid St NW, confirmed to be stepping off in 10 minutes and will be traveling southbound on Georgia Ave NW with the final destination being Lafayette Square. As of 1420 hours, there is a group of approximately 100 demonstrators traveling northbound on Georgia Ave NW to meet with the group at Howard, some of which are reportedly carrying Antifa posters. As of 1429 hours, the group of approximately 300-400 is preparing to step off. As of 1435 hours, the tail just passed Bryant St NW, continuing southbound on Georgia Ave NW. As of 1439 hours, the tail just passed W St NW, continuing southbound on Georgia Ave NW. As of 1441 hours, the tail just passed V St NW, continuing southbound on 7<sup>th</sup> St NW. ### **HOURLY SITUATIONAL BRIEF**

As of 1613 hours, the event organizer of the March from Howard has notified MPD that the event is over and they intend to leave.

As of 1620 hours, per USPP, approximately 7 individuals have breached the fence on the H St NW side in Lafayette Park, at least 3 of the individuals have spray paint containers. Additionally, there are about 7-10 on the roof of the comfort station located at 16<sup>th</sup> St NW and H St NW. As of 1622 hours, there are several breaches to the first security barrier and approximately 250 demonstrators are inside of Lafayette Park. At least one individual inside the fence is armed with an aluminum baseball bat.

As of 1650 hours, USPP units have eyes on a man with a possible firearm in the area of 16<sup>th</sup> St NW and H St NW. Subject is wearing a red shirt, with a black backpack, camel colored facemask. They advised nothing additional needed at this time.

As of 1654 hours, USPP reporting projectiles are beginning to be thrown at officers at Lafayette Park.

As of 1658 hours, Cruiser 50 advises of suspected individuals storing missiles in the 600 block of 14<sup>th</sup> St NW. Motor 2 canvassing. Cruiser 50 requested DPW to stage at the Wilson Building. They have been advised.

As of 2247 hours, there is a large group of demonstrators gathered in the park between 10<sup>th</sup> St NW and 11<sup>th</sup> St NW.

As of 2250 hours, subjects are looting and breaking windows inside the CVS at 900 11<sup>th</sup> St NW.

As of 2252 hours, there is a vehicle on fire in the 1600 block of I St NW. Additional vehicle fire in the 1500 block I St NW. As of 2257 hours there are multiple vehicles on fire in 1600 block of I St NW



As of 2255 hours, the Conrad at 950 New York Ave NW is being broken into. OC spray authorized in an effort to deter looting and destruction of property.

As of 2255 hours, 15<sup>th</sup> and K St NW, reports of destruction of property.

As of 2256 hours, call to redeploy to support 1D with looting/fires.

As of 2304 hours, reports of MPD vehicle on fire by Mt Vernon Convention Center/Carnegie Library.

As of 2306 hours, stinger deployment (possibly H and Vermont NW).

As of 2308 hours, confirmed structural fire at 815 16<sup>th</sup> St NW.

As of 2313 hours, reports of about 50 subjects in the 1800 block of L St NW with bats smashing windows and looting. The group is making a loop toward Connecticut Ave NW and K St NW.

1600 to 2100 hours: According to open source information, [REDACTED] and others will assemble at the Washington Monument and march to the Lincoln Memorial to conduct a vigil for George Floyd and a march for police reform. (212) people has expressed interest in this event.

1700 hours: According to open source information, a group will assemble up on Macarthur Blvd and conduct a "driving vigil procession" along Goldsborough, down to Massachusetts Avenue. The final designation is not known.

1930 hours: According to open source information, Black Lives Matter will assemble at McPherson Square in opposition of police brutality. The number of participants is unknown.

2000 hours: According to open source information, a group is planning on assembling at Saks Fifth Avenue located at 5300 Wisconsin Avenue NW for a First Amendment Demonstration. The number of participants is unknown.



2200 hours: According to open source information, multiple groups are planning to assemble at an unknown location in D.C. Although the location is not listed, this is the same organizer who assembled the groups at 16th and H Streets, NW, on May 29th and 30th.
