As of 0206 hours, 1 arrest was made at 1420 New York Avenue, NW for APO and throwing missiles, one use of force (takedown). As of 0208 hours, DPW was contacted through the JAHOC to address the debris on I Street, NW, between Vermont Avenue and 17th Street. As of 0211 hours multiple use of force incidents reported, OC sting balls deployed, group throwing bricks and missiles. OC spray deployed. 1 air burst (scat round) deployed.
