As of 2301 hours, the group is SB on Connecticut Ave NW crossing M St NW. As of 2306 hours, the group is SB on Connecticut Ave SW toward Desales Pl NW. As of 2308 hours, the group continues SB on Connecticut Ave NW crossing L St NW. As of 2310 hours, the group is EB on K St NW approaching 17<sup>th</sup> St NW. As of 2314 hours, the group is SB on 16<sup>th</sup> St NW from K St NW entering BLM Plaza. As of 2318 hours, the group is holding at 16<sup>th</sup> St NW and H St NW. As of 2319 hours, multiple subjects are jumping on the barriers in the area of the chute at St. Johns Church. As of 2320 hours, members of the group are throwing projectiles at officers and are coming inside the barriers of the chute. As of 2321 hours, glass bottles are being thrown at MPD personnel and helmets for the CDU line in the chute. As of 2323 hours, on the north side of Vermont Ave NW and H St NW helmets are authorized per Cruiser 50. As of 2324 hours, Wagon requested in the 800 block of Vermont requested by Cruiser 50 for 1 in custody. Smoke authorized and deployed at 2325 hours by Cruiser 50 at Vermont Ave NW and H St NW. OC deployment by Sgt [REDACTED] in self-defense at 2326 hours at Vermont and H St NW. Multiple smoke deployments at 2327 hours as subjects throwing rocks and bottles. As of 2327 hours, MPD units are taking bricks. As of 2328 hours, injured Officer and sting ball deployment. As of 2329 hours, APO in area of 16<sup>th</sup> St and H St NW. As of 2330 hours, sting ball deployment as subjects throwing fireworks at officers. As of 2330 hours, 1 arrest in front of Hay Adams for APO. As of 2331 hours, Cruiser 50, recovered an improvised device that was possibly used in APO of officer. As of 2332 hours, officers taking more projectiles, smoke deployment authorized by Cruiser 50. As of 2332 hours, sting ball deployment as officers are taking on tear gas from subjects. As of 2333 hours, officers taking on more projectiles and **Felony Riot declared.** Sting ball deployment authorized at 2333 hours as more projectiles are deployed at offices. As of 2333 hours, additional sting ball deployments authorized at NE corner of 16<sup>th</sup> St NW and I St NW. As of 2336 hours, officers are still taking projectiles in the area of 16<sup>th</sup> St NW and I St NW. As of 2338 hours, more glass bottles are being thrown at officers, aerial munitions authorized by Cruiser 50. As of 2339 hours, second aerial munitions authorized at 16<sup>th</sup> St NE and I St NW. As of 2339 hours, officers still taking incoming projectiles. As of 2340 hours, rioters are attempting to break into the St Regis Hotel (16<sup>th</sup> St NW and K St NW). As of 2341 hours, per Cruiser 5, rioters continue to shoot fireworks at officers. As of 2344 hours, aerial munitions authorized by Cruiser 50 on the north side of 16<sup>th</sup> St NW and K St NW. As of 2352 hours, Cruiser 50 authorized sting balls at 16<sup>th</sup> St NW and K St NW. As of 2353 hours, additional sting ball deployment at 16<sup>th</sup> St NW and K St NW. As of 2358 hours, trashcan fire in the area of the Capitol Hilton (NE side of 16<sup>th</sup> St NW and K St NW). As of 0000 hours, devices with smoke being thrown at officers. As of 0005 hours, the police line is pushing NB on 16<sup>th</sup> St NW north of K St NW. As of 0005 hours, 1 arrest of the van driver. As of 0007 hours, one sting ball deployment at 1000 16<sup>th</sup> St NW. As of 0014 hours, sting ball deployment at 16<sup>th</sup> St and L St NW. As of 0020 hours, per Cruiser 50, they broke contact.

As of 0024 hours, in the area of 18<sup>th</sup> St NW and Connecticut Ave NW, the white van and the trailer are spotted and may be carrying multiple rioters.
