## **HOURLY SITUATIONAL BRIEF**

At 1128 hours, the group at Freedom Plaza (hereafter *Group 1*) stepped off westbound on Pennsylvania Avenue NW, towards 15<sup>th</sup> Street. At 1134 hours, Group 1 had completely vacated Freedom Plaza and was headed southbound on 15<sup>th</sup> Street NW. At 1136 hours, a two-tone blue Harley Ultra motorcycle was seen in the tail of Group 1, as the tail approached 15<sup>th</sup> and Pennsylvania Avenue NW. ## **HOURLY SITUATIONAL BRIEF**

At 1211 hours, about 15 counter-demonstrators were at Madison and 15<sup>th</sup> Street NW. At 1215 the group split into two parts, one heading towards the Washington Monument, another moving southbound on 14<sup>th</sup> Street NW. As of 1220 hours the counter-demonstrators at the Washington Monument (now at 15<sup>th</sup> St NW and Jefferson St NW) were estimated at 25-30 people. At 1226 they were observed chanting anti-law enforcement slogans. As of 1236 about 10 of them were walking westbound, and the rest of the group stayed at the monument. As of 1238 two more were walking westbound, one with a bullhorn. At 1253 the man with the bullhorn was seen in the middle of the crowd.

At 1215 hours, temporary road closures were requested at Connecticut Avenue and K Street Southbound and Pennsylvania and 17<sup>th</sup> Street NW southbound.

At 1215 hours, Group 1 was at the World War II Memorial on 17<sup>th</sup> Street NW. At 1244 Group 1 had moved to the Sylvan Theater (15<sup>th</sup> Street NW and Independence Avenue SW, just southeast of the Washington Monument), stationary, estimated at 500-600 individuals.
