PROGRAM OF EVENTS

A BRIEF HISTORY

In 1790, Maryland and Virginia ceded portions of their territory for the purpose of establishing the Federal City. For the next 10 years, the Federal City was policed by constables appointed by these two states. In 1802, when the original

charter of Washington was approved, police authority was centralized and power was granted to the city itself to establish patrols, impose fines, and establish inspection and licensing procedures. Until the creation of the Metropolitan Police Department in 1861, the city had only an auxiliary watch with one captain and 15 policemen.

In 1861, President Abraham Lincoln took personal interest in founding a regular police department for the District of Columbia. It was a time of constant danger in the Nation's Capital. With the beginning of the Civil War, an army was billeted in the city, government employees were increased by ten-fold, and hordes of unsavory elements descended upon the District's few square miles. President Lincoln personally

dispatched an emissary from the newly created Board of Metropolitan Police Commissioners to New York City to become familiar with that system, which itself was based on the world-acclaimed Metropolitan London Police Department.

The ideas and knowledge gained from this study led to the creation of the Metropolitan Police Department on August 6, 1861. In September of that year, attorney William B. Webb was appointed the first Superintendent of the Police, with an authorized force of 10 sergeants and a number of patrolmen as needed, but not to exceed 150. Up to 10 precincts were authorized. The Superintendent of Police was paid \$1,500 annually, with sergeants earning \$600 and patrolmen \$480.



The sergeants and most of the personnel for two precincts were sworn in that September. Officers had to be US citizens, able to read and write the English language, have been DC residents for two years, never convicted of a crime, between 25 and 45 years of age, and at least five feet, six inches tall. The men went to work right away in 12-hour shifts, seven days a week with no days off and no vacations. They were issued neither equipment nor badges, and they

had to obtain their own handguns. The first arrest made by a Metropolitan Police officer was on a charge of intoxication.



In 2008, MPD began building a partnership with the Department of Mental Health. We did this not only to improve the training of our officers, but also to improve our delivery of services to our community. Our first CIO course started on April 27th of 2009, with only 21 officers. That number has grown and 212 Crisis Intervention Officers have now been trained.

DMH has played a vital role in the training of each of these officers. They also play a vital role in the work of these officers after they have returned to their PSAs.

The Department of Mental Health has been with us every part of the way and for that we recognize their efforts tonight.

DC Department of Youth Rehabilitation Services (DYRS)

he District of Columbia Department of Youth Rehabilitation Services has been our partner in multiple initiatives that have increased the supervision of youth in the community and protecting the public. The CCJAI pilot is a forum where information is shared among DC's law enforcement agencies with the focuses on crimes.

MICHAEL ROBINSON United States Postal Service

r. Robinson, a United States Postal worker is an exemplary citizen and is being recognized for his heroic efforts to assist an elderly resident who had been beaten after walking in on a robbery of her home. Mr. Robinson was completing his route, when he observed a bloodied and dazed resident screaming for help, and he observed someone running from the scene. The resident explained that she had been beaten with a crowbar by a robber in her home. Mr. Robinson assisted the resident with getting emergency care, and followed in the direction the suspect was running. Mr. Robinson was able to track down the alleged suspect and maintain a vigilant watch until law enforcement officials could arrive on the scene. During the encounter, Mr. Robinson followed the suspect and kept a close watch on his every move until police arrived.

OUTSTANDING BUREAU EMPLOYEES

n 2009, Mr. McReynolds was hired as a Compliance Monitor in the ORM. The contributions Mr. McReynolds has made to the MPD and DC Government since his arrival exceeds expectations. During challenging budget and fiscal constraints, Mr. McReynolds has recovered \$471,843.69 and identified



another \$1,246,340 all to be deposited into the DC Government. Also, he is reducing the time members remain on POD sick leave.

Mr. McReynolds created a structure with the cooperation of the Medical Services Division, Fleet Management Division and the Payroll Unit to identify and process all future subrogation. He estimates that there is an additional 2-3 million dollars recoverable that has not been processed. Due to the work Mr. McReynolds has done, members on Performance of Duty injuries/illness are returning to work sooner once they are contacted by him that all lost wage settlement money collected shall be returned to the Department forthwith. He has had a significant impact on the operations of the MPD.

LIEUTENANT BRIAN CALLEN Investigative Services Bureau

ieutenant Brian Callen is an extremely valuable employee who serves as the administrative officer for the Investigative Services Bureau. and crime patterns of his beat in great detail. As a result, Officer Hashida has made 170 arrests this year (2010); Four (4) of the arrests involved firearm seizures (MI Carbine Assault Rifle, Colt 1911, AMT Hardballer, 380); Sixteen (16) of the arrests involved narcotic violations that have resulted in the seizure of 83.4 grams of cocaine, 4,420 grams of marijuana, and \$5,872.90 in U.S. Currency. aptain Byron Hope is assigned to the Seventh District as the evening tour watch commander. Captain Hope has displayed a take charge attitude and has developed productive relationships with his coworkers and the residents of his three PSAs. He shares information readily with the



members of the 7D Listserv and responds to their listings during all hours of the day and night. Captain Hope stays abreast of the crime trends in his areas and has led his members in initiatives to address them. He has willingly shared the vast knowledge learned from previous assignments with 7D officers and officials to help develop their skills as law enforcement professionals. PSAs 703 and 704 have historically been two of the most problematic areas in the Seventh District. Under the leadership of Captain Hope during FY 2010, PSA 703 achieved a 28 percent reduction in violent crime, a 30 percent reduction in property crime, and a 29 percent overall crime reduction. or 2010, the Sixth District had another year where crime was reduced (they led the city in 2009) and again reduced it by 4 percent overall. They also lead in the city with 7,521 arrests and had the secondhighest gun recovery of 167 weapons removed from the streets. 2010 marked the year when the Sixth District became the place where new officers, officers who were being transferred to Patrol, and newly-promoted officials requested to be assigned.

The District's leadership team led a major decrease in use of sick leave, equipment loss, and overtime budget — a decrease of 47 percent this year. The Sixth District has augmented their foot patrols in areas of need, including new areas of focus. Officers diligently walk their footbeat, and use their Segways as well as mountain bikes. Relationships with citizens in areas where — for a long time — residents did not feel served or protected, have vastly improved, and there is community-wide participation at both PSA meetings and events. The Sixth District also led this summer in the Sixth Sense Initiative — where violent crime was reduced by 59 percent. The Sixth District was also the district that led the city in use of our new technology — iMobile and RMS. Members in 6D led in daily logins and kept the lowest number of outstanding reports. They also assisted in quality assurance tracking for new projects, which led to a quality product for all officers to use.

CRIME REDUCTION AWARD


Awarded annually to all MPD sworn, civilian, and reserve corps members of the district which realizes the most significant reduction in crime, as measured by comparing present year statistics with that of the previous year.



First District

Patrol Services and School Security Bureau

he First District is recognized for being the District with the greatest reduction in crime for 2010. This team had the highest reduction overall in the city of 14 percent. The District also recorded a 12 percent reduction in violent crime, including a significant reduction in homicides (nine this year). In addition, the First District achieved a 15 percent reduction in robberies in 2010. The members of 1D achieve results through proactive initiatives and teamwork. They also had significant arrests/closures that assisted in reducing crime throughout the year.

CRIME SUPPRESSION TEAM OF THE YEAR

Presented to members of the street crimes unit within a police district responsible for reducing crime in a specific geographic area by utilizing various police tactics, such as making significant arrests, conducting search warrants, and seizing drugs, guns, money, and other contraband.



THIRD DISTRICT STREET CRIMES UNIT Patrol Services and School Security Bureau/Third District

he Third District Crime Suppression Team recorded 932 arrests (including 26 for Robbery, 35 for Carrying a Pistol without a License); recovered 80 guns; conducted 49 search warrants; seized 49 vehicles; and seized more than \$132,000. The 3D CST is comprised of two sergeants and 20 officers who compiled these impressive statistics. The notable arrests include homicide suspects as well. Third District command staff regularly gives CST special assignments in targeted areas and they often produce results. They are a cohesive and dependable unit who come through in stellar fashion. Throughout the year, the Executive Command Staff has repeatedly praised their performance. Their overall efforts are certainly worthy of recognition.

PATROL SUPPORT TEAM OF THE YEAR

Presented to the Patrol Support Team (PST) group which has made the greatest impact on crime during the previous year by augmenting the regularly assigned patrol members to reduce crime and violence throughout the city.



PST GROUP B Various Bureaus and Elements

uring calendar year 2010, each member assigned to PST Group B, has demonstrated their commitment to fighting crime. Being deployed in high crime areas to combat crime is a staple of police work, but each of these members comes to PST with a positive attitude realizing their importance in the overall crime fighting strategy of the Department. Be it on a hospital detail, large crime scene, or Traffic Safety Compliance Checkpoint, no matter the weather, each member accepts their assignment without a second thought or questions why me? Other significant areas of success include answering on average of 400 radio runs within a week which takes a huge burden off of the District's resources. Additionally, each of these members brings a unique skill set to PST as well.





VICE UNIT OF THE YEAR

Presented to the district vice unit that made the greatest impact on enforcement of narcotic and prositution offenses in their community by targeting these persistent problems, establishing effective plans, and executing them with significant results.



FIRST DISTRICT VICE UNIT Patrol Services and School Security Bureau

he following CY10 productivity of this unit supports the nomination: 858 total arrest — inclusive of 186 felonies. They conducted 77 searches; seized narcotics and cash, including 1,246 pills and 1,645 Ziplock bags of cocaine and 397 grams of cocaine, as well 809 Ziplock bags of marijuana, 5,294 grams of marijuana, and 1,030 Ziplock bags of heroin. In addition, the team seized 10 grams and nearly \$53,000 in US Currency for forfeiture. During Operation Sixth Sense, the First District Vice Unit worked in the Third District from May 1 to August 1, 2010, in the 7th and O Streets, NW Area investigation. This effort resulted in 27 arrests and five search warrants.

A separate investigation in the 1300 block of 7th Street, NW, resulted in five additional search warrants. In addition, the investigation resulted in numerous drug buys and eight Grand Jury indictments. The vice unit was a key component of the ongoing nuisance property investigation at Tyler House from August 1 to October 30, 2010. The investigation yielded 66 arrests and 14 search warrants, as well as the identification of five major drug targets. In 2010, MPD arranged a meeting with the property owner, OAG and CSOSA to discuss issues at the building and to negotiate a civil settlement for this nuisance property. The work of the vice team is an integral part of our successes at 1D.

PSA OF THE YEAR

Presented to the members of the Police Service Area which showed the greatest improvement in reducing crime, exhibited innovation in crimefighting and solving, and made the most impact on the community in which they serve.



POLICE SERVICE AREA 703 Patrol Services and School Security Bureau/Seventh District

SA 703 encompasses some of the most challenging neighborhoods in the city, to include the Barry Farm Public Housing Community. Members of PSA 703 have worked diligently to enhance the quality of life, reduce crime and the fear of crime in their PSA. They have worked with the community stakeholders and the Douglass Road campus of the KIPP Academy Public Charter School in mediating operational and traffic concerns with area residents. Through their efforts, residents and a much needed educational institution have been able to coexist in a area under transition. Additionally, after receiving reports that students attending the KIPP Academy had become targets for robberies and assaults by other area youth, PSA 703 members developed a safe passage program to ensure students can focus their full attention of education and not have to worry about becoming victims of crime upon their dismissal from school. As a result of the hard work and dedication of the officers and officials of PSA 703, they have achieved an 18 percent reduction in violent crime, a 22 percent reduction in property crime, and a 21 percent reduction in overall crime. Most notable is a 56 percent reduction in homicides in this PSA.
