

## Misconduct Resulting in Adverse Action (2023)

**Report Note:** Pursuant to the Secure DC Omnibus Amendment Act of 2024, effective June 8, 2024 (D.C. Law 25-175), misconduct determinations resulting from vehicular pursuits and neck restraints are under review by the Department. The determination and any resulting discipline may be subject to change as a result.

**Note for Penalty:** Total days represent the number of days assessed to be suspended without pay (SWOP). This does not necessarily mean that all of the days will be served. In some cases, the employee may be allowed to forfeit days of accrued annual leave ("leave forfeiture") in exchange for SWOP days. More commonly, some days of penalty may be held in abeyance for a year. If the employee is involved in additional misconduct during that time, he or she will be required to serve those SWOP days. This is reflected as "days held" for current cases, or as "plus some days from prior case." The total days spent suspended without pay = total days - days held - days leave forfeiture + any days from prior case.
