NOTES:

The "Home PSA" of all arrests for which a valid District of Columbia was given are provided. For all cases for which a street address outside the District of Columbia was reported or no address was recorded, an NA has been recorded in the Home PSA field.

The Crime/Arrest field contains the PSA associated with the original crime in those cases where the arrest could be matched against the original crime report based on the original complaint number. For those cases for which no match could be made, it was assumed that the arrest was made at the site of the crime. In these cases the PSA associated with the arrest location has been provided. Cases for which the Juvenile Processing Center was indicated (most often Juvenile Custody Order - Court Charge, Failure to Appear, and Booking Order), JPC was listed as the crime PSA.
