he Metropolitan Police Department periodically invites the immediate family members of open homicide cases to join us for a special, personal Next-of-Kin Meeting with a homicide detective. MPD wants to reassure families that their loved ones' cases have not been forgotten. The meeting is designed to give families an opportunity to meet, one-on-one, with the assigned detective to discuss their loved one's homicide case. The first Next-of-Kin meeting was held in May 2007 at the Metropolitan Police Academy on Blue Plains Drive, SW. Meetings are now held at 101 M Street, SW, at MPD's Homicide Branch for current year cases; Next-of-Kin meetings for older unsolved homicide cases are held at 300 Indiana Avenue, NW.

While waiting to meet with detectives, families get information about their rights as victims; literature on grief and trauma; Crime Victims Compensation materials; and information on the MPD Evidence Control Branch. Families are also connected with system and community-based service providers to address their diverse needs.

Families are encouraged to participate in future Next-of-Kin meetings. Based on the age of the case, your point of contact will be from one of two MPD units — the Family Liaison Specialists Unit at (202) 645-6363 or the Major Case Victims Unit at (202) 724-4339.

Frequently Asked Questions About Autopsy Reports

Q: How do I obtain a copy of my loved one's autopsy report?

A: Next of kin may request an autopsy report for their loved one in writing, or in person at the Office of the Chief Medical Examiner (OCME) located at:

Q: What documentation do I need to provide to the Office of the Chief Medical Examiner?

A: The Office of the Medical Examiner requires all persons requesting an autopsy report to notify the OCME Medical Records Division at (202) 698-9111 prior to coming by the office. The requester must provide a government-issued ID and a check or money order made payable to the DC Treasurer for \$15.

Requests made in writing may be sent to the above address and must include the following information:

- » Name of person making request
- » Relationship to the decedent
- » Name of the decedent
- » Date of death
- » OCME case number (can be found on death certificate)
 All written requests must in-

clude a check or money order made payable to the DC Treasurer for \$15. The request will be processed and mailed out in two to three business days.

Q: If my loved one's remains were taken to the Maryland State Medical Examiner's Office, who should I contact for information on obtaining a copy of the autopsy report?

A: For information on obtaining a copy of your loved one's autopsy report from the Maryland Office of the Chief Medical Examiner's Office, please call (410) 333-3249.

Outreach in Motion

he Victim Services Branch (VSB) of the Metropolitan Police Department is committed to assisting victims of crime and highlighting the resources available to the families and survivors of homicide cases. In our continued efforts to support and empower families, VSB works effortlessly to ensure that we are attentive and responsive to all victims' needs. To adhere to our missions, the VSB has participated in many events throughout the city to provide awareness of the supportive services.

» The National Day of Remembrance for Murder Victims (Commemorative Ceremony) was held at the National Press Club, 529 14th Street, NW, Washington, DC, on Saturday, September 25, 2010. It was sponsored by the Maryland Crime Victims Resource Center, Inc. MPD was selected to participate in a panel forum as a "Discussion Leader" for the Public Forum. Over 50 individuals, including survivors, the general public, professionals in the victim field, and policy makers, » were in attendance.

The Victim Services Specialists met with residents and staff from the Salvation Army Residential Treatment Center, located at 2100 New York Avenue, NE, monthly throughout 2010 to provide information on the Victim Services Branch. The Salvation Army Residential Treatment Center is a local community residential treatment facility that provides housing for men and women who have a history of substance abuse. The goal of the Salvation Army Residential Treatment Center is to assist the men and women in their facility by providing daily case management, counseling sessions, and referrals to alternate community agencies that would assist them in obtaining a level of independence. The staff believes that the services of Victim Services Branch are very beneficial for the residents and would help those who were victims of a crime.

The Emery House (Residential Facility), located at 1725 Lincoln Road, NE, Washington, DC, is an organization that provides temporary housing to men who are recovering from substance abuse. On Tuesday, July 20, 2010, the Victim Services Branch was invited to provide information during the daily meeting held for the substance/alcohol abusers to openly discuss their addiction and the progress in the program for recovery. Information included materials on MPD's Victim Services Branch / Family Liaison Unit, Major Case Victims Unit, Victim Specialist Unit, Crime Victims Compensation Program, DC Common Grief, VINE, domestic violence, and stalking. We had the opportunity to hand-out several pamphlets and speak with several individuals about the Victim Services Branch Units.

Victim Specialists Unit

t the forefront of victim services, MPD's Victim Specialists Unit is a part of the Victim Services Branch. The unit helps all sexual assault victims District-wide and offers aid to domestic violence victims. Specialists primarily assist victims of domestic violence, sexual assault, and stalking. Specialists obtain police reports and referrals citywide; they also conduct a targeted case management approach for cases in PSAs 705, 706, 504, 602, 603, 604, and all of the Fourth District. When a victim specialist is called, he or she informs the victim of his or her rights, offers supportive listening, provides crisis-intervention, and provides information and referrals to appropriate agencies. The victim specialist may share information with the victim on the case status or encourage the victim to keep in touch with the detective working on the case. En-

couraging victims to participate in the criminal process helps victims achieve a sense of justice even if the perpetrator is never charged.

The most important goal for the victim specialist is to ensure the victim's safety. That safety can be achieved through relocation or obtaining a civil and/or criminal protection order. Victim specialists may forward a referral for emergency housing or provide court accompaniment during court proceedings. The victim specialist works with the victim to strengthen measures put in place to keep them safe.

Another critical role the Victim Services Branch offers is community outreach. This year, the Victim Specialists Unit took a different approach in educating the community. During Domestic Violence Awareness Month in October 2010, the Victim Specialists Unit made presentations at Wingate Towers & Garden Apartments, Vista at Edgewood Terrace, the Vantage at Edgewood Terrace, and Columbia Heights Apartments. They also conducted outreach in designated focus improvement areas. They empowered the community and victims by providing information and explaining the importance of prevention and reduction of victimization. The Victim Specialist Unit also continued its cell phone drive efforts and held information sessions for the mayor's focus improvement areas.
